




## Access to Health Care

Access to quality healthcare services is essential for disease prevention, early detection, and effective treatment, improving overall health and increasing life expectancy.




#### FOCUS ON HEALTHCARE ACCESS & Quality

21 (58.3%) agencies focus a lot on Healthcare Access and Quality, which is the connection between people's access to and understanding of health services and their own health. This includes issues such as access to healthcare, access to primary care, health insurance coverage, and health literacy.



**63.2%** 24 agencies **currently perform** Access to Care. **10.5%** 4 agencies want to perform Access to Care.









#### MOST IMPORTANT FACTORS 40.5

Responses to "Please indicate whether you think you have easy access (or the ability to find and receive services) to each of the following." (n=888)













Economic stability directly impacts health, as financial hardship limits access to basic needs like healthy food, safe neighborhoods, and healthcare, leading to poorer health outcomes.



#### ACCESS TO SPECIFIC SERVICES


25 agencies (67.6%) provide services "specifically" for individuals with low income- individuals who fall

#### FOCUS ON ECONOMIC STABILITY

20 (55.6%) of agencies focus a lot on Economic Stability: The connection between people's financial resources-income, cost of living, and socioeconomic status-and their health. This includes issues such as poverty, employment, food security, and housing stability.

#### CHILDCARE IN BENZIE

"This photo represents childcare in our community-both gratitude for the loving care from the folks inside it, but also drawing attention to the limited resources they work with. In Benzie County, there are limited year-round options for children of all ages. Buildings are challenged by maintenance costs. Teachers are challenged by low wages and poor (or no) benefits. Parents cobble together care to meet the minimum care needed to maintain jobs."









## Education

#### MITHRIVE REGIONAL ISSUE BRIEF

Education is a key determinant of health, as higher educational attainment is associated with better health choices, increased access to healthcare, and longer life expectancy.



#### EDUCATION ENGAGEMENT

26 (70.3%) of agencies actively engaged with education more than once in the last year. This is compared to 25 (67.65%) with early childhood development/childcare and 20 (54.1%) with Youth Leadership and development more than once in the last year.



#### FOCUS ON EDUCATION

19 agencies (52.8%) focus a lot on Education Access and Services, which is the connection of education to health and well-being. This includes issues such as graduating from high school, educational attainment in general, language and literacy, and early childhood education and development. This is compared to 12 (33.3%) that focus "a little" and 5 (13.9%) that "do not".






Responses to "In the following list, which five assets do you think are the most important factors for a community to be considered thriving?" (n=888)











## FOCUS ON EDUCATION ACCESS & SERVICES

16 (44.4%) of agencies focus "a lot" on Neighborhood and Built Environment, which is the connection between where a person lives housing, neighborhood, and environment— and their health and well-being. This is compared to 18 (50.0%) that focus "a little" and 2 (5.6%) that "do not."



#### ORGANIZATIONS PERFORMING ASSESMENTS

24 (64.9%) agencies "currently perform" Assessment: My organization conducts assessments of living and working conditions and community needs and assets. This is compared to 3 (8.1%) that "would like to" and 10 (27%) that "do not."










#### **BARRIERS TO ACTIVITY**

Responses to "Do any of the following issues currently prevent you from being more active in your community?" (n=888)















#### ENGAGED IN BEHAVIORAL WORK


26 (70.3%) agencies have actively worked on mental or behavioral health (e.g., PTSD, anxiety, trauma) in the past year.

#### SERVICES PROVIDED


#### ENGAGEMENT









#### MOST CONCERNING MEDICAL CONDITION


Responses to "In the following list, what do you think are the three most concerning medical conditions impacting your community? " (n=888)






#### MOST IMPORTANT CONCERNS





3 (13.5%) agencies actively engage with violence more than once in the last year.




Responses to "In the following list, which five assets do you think are the most important factors for a community to be considered thriving?" (n=888)
